## भिवंडी पा... प्रकरण : सव

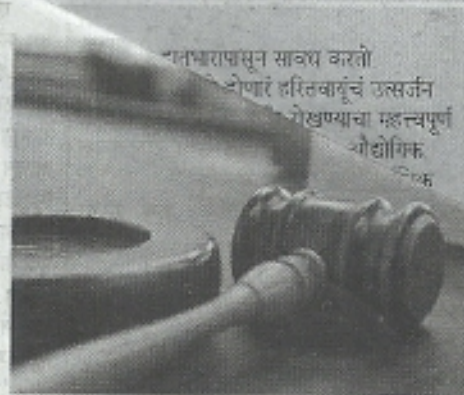
